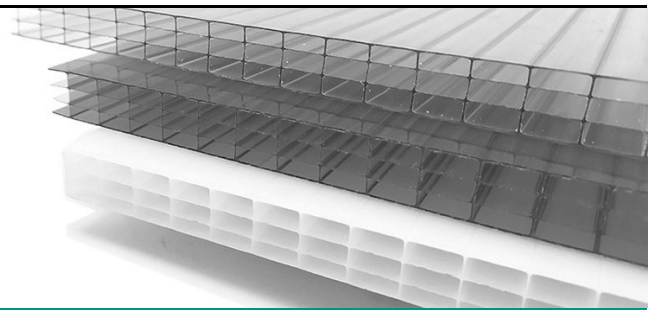


POLYCARBONATE SHEET

Fourwall (Four) Thicknesses 8mm



Ten Years of Limited Warranty Guarantee:

Scope of guarantee: from the date of purchase, there will be no excessive aging within 10 years. Including:

1. The sheet is broken due to natural aging;
2. If the test result meets the scope of clause (1), the sheet can be replaced free of charge. This warranty does not include reimbursement of reinstallation costs, or other direct or indirect losses caused by damage to the sheet.
3. It can withstand the hail velocity of 16mm in diameter within 15m / s.


Guaranteed execution conditions

1. This guarantee is only for the PC sheet with UV protection layer on the surface, and correctly install the surface protection layer towards the sun.
2. During the warranty period, when there is a natural breakage replacement, the buyer should pay the depreciation cost of the product used (according to 1.0% of the original purchase price per month).
3. Washing and maintenance must be carried out in accordance with the methods specified by our company. The company will not accept any problems caused by improper cleaning and maintenance methods.
4. The improper storage, transportation, handling and installation by the user will cause physical and chemical changes and damage to the sheet, and the company will not be responsible.
5. The consequences caused by wear, scratches, exposure to corrosive substances or harmful chemicals are not guaranteed.
6. The disassembly without notifying our company is not within the scope of the warranty.
7. The repair costs paid for natural disasters, contingency, and special damages (including man-made damages) will not be borne by the company.
8. There is no guarantee for the negative effects caused by improper use of connection and fastening profiles and sealing materials.
9. The company is not responsible for the damage to the sheet caused by the failure to install according to the company's technical manual.

Special Notes:

This guarantee can replace any other form of guarantee, including written or oral, explicit or implicit, commercial or other purposes. If Polycenter S.A. cannot provide replacement sheet within a reasonable period of time, which reserves the right to compensate customers at the purchase price. When there are quality problems with the sheet, the user must provide the original invoice or the original valid bill within 15 days of the company or the designated agent. The original letter of guarantee from Polycenter S.A. and the defective sheet formally complete the appeal form. The company reserves the right to take samples on site. The samples obtained must be processed according to the cleaning methods specified by the company and tested according to the test standards specified by the company. When the installation and use length: Hollow Sheet > 8m, Solid Sheet > 8m, it is not covered by the warranty.
